Intro to National College

- you have an account to the National Online Safety section as a Parent/Carer
- Where to find the guides scroll down or click on LIBRARY

First thing to talk about is the school's subscription to National College and more specifically, National Online Safety. This website is a big hub of information that parents can access for free. I will explain more about how to access your account later on in the video but you need to know that you have to request an account. Once you have logged in you will find this page and can then access the library of guides and webinars. --- As you can see, there is so much to read about. I think the key thing to know is that if you are not sure about a particular issue, you can come here to learn more about it in case you need that info later down the line to discuss with your child. So, let's choose one to dive into now....Microtransactions.

Microtransactions guide

- Very common in all forms of gaming console or mobile
- Enhances addiction
- Financial risks
- Links to gambling harms (loot boxes)

I can imagine that as a parent it is a big exercise in trust that your child will use the internet and gaming safely. One element of gaming that can be quite costly is Microtransactions. An example of this would be Roblox. This online game lets young people enter virtual shops and games. If they want to buy anything they need to use Robux, an in game currency which can be bought with real world money. The risks are real - lots of money can be spent without a young person realising it has built up, addiction levels can start or increase and young people can create harmful gambling behaviours. Another example of this would be Loot Boxes which have been made famous on FIFA/EAFC.
